1. The Board of Directors is the governing body of the Dayton Area Board of REALTORS®. The major function of the Board of Directors is to establish board policy and procedure. The directors usually meet once each month.
2. Four directors terms and a president elect are needed to serve three-year terms beginning January 1, 2012. Additionally, one single year director position will be filled. The President Elect will automatically become President in 2013, then serve as Past-President in 2014.
3. Applicants must have been a member of DABR for three years.
4. The Nominating Committee will schedule individual meetings with members interested in being a candidate on June 23 and July 7, 2011. Following the meetings, the committee will select candidates. A profile of each candidate will be published in the October issue of the *Dayton Area REALTOR®*. Ballots will be made available online to the entire membership in October. Election results will be announced at the annual Membership Appreciation Luncheon scheduled at the Marriott Hotel.
